The **EFRI Summer School** is a summer programme created at the Faculty of Economics in order to extend students' knowledge in a stimulative environment situated in the Mediterranean and mountain area.

The **Faculty of Economics**, with three dislocated study centres, is the largest faculty of the University of Rijeka with almost 3,000 full-time and part time undergraduate, graduate and postgraduate students

The Faculty was founded in 1961. Its basic mission was to educate economic experts to meet the needs of the regions of Primorje and Istria. In the course of its existence, the Faculty has adjusted its curriculum, scientific and educational activities, technical equipment and its human resources to the changing needs of industry, maritime transport, entrepreneurship, financial and other services.

From its beginnings, the Faculty of Economics has successfully developed international co-operation with numerous institutions of higher education throughout the world.

The University of Rijeka was established in 1973. However, the first school of higher education was established in 1627 by the Jesuits.

The University, located in three counties and four cities, is presently comprised of ten faculties, three teachers training colleges, two university libraries and a students centre.

## SUMMER SCHOOL

### THE SUMMER SCHOOL

The goal of the EFRI Summer School is to broaden the knowledge of students of economics, law and other related studies about basics of the economic integration process in Europe (focusing on Croatia and South East Europe), and to point out the advantages and challenges of economic integration in everyday life. The course work will consist of lectures, workshops and an assignment to be completed in groups with the support of course supervisors. Due to its specific approach to the European Union & the International Environment, this course will suite both the students who already have a basic knowledge of EU matters and those who want to know more.

The Summer School programme is developed in cooperation with the local community, successful Croatian companies and domestic and foreign institutions. Classes will be held by lecturers from European and Croatian universities and by experts coming from state and other institutions. Classes are completely in English and will be held at the Faculty of Economics Rijeka. Participants will learn about Europe and will be awarded **6 ECTS credits**.
