

PUBLICATION ETHICS

Journal of Economy and Business of the Faculty of Economics University of Mostar (Zbornik radova Ekonomskog fakulteta Sveučilišta u Mostaru) adheres to the highest standards of editorial work ethics, the principles of Code of Ethics of the University of Mostar as well as the principles of the COPE Code of Conduct for Journal Editors.

The Editor-in-Chief/Editorial Board continuously works to improve the quality of papers, overall journal and adhere to intellectual and ethical standards. The Editorial Board must not have a conflict of interest in relation to the papers is considers for publication. The Editorial Board must evaluate the papers received without any racial, gender, sexual, religious, ethnic or political discrimination.

The Editor-in-Chief/Editorial Board may not use unpublished material given in the submitted papers without the written approval of authors. Editor-in-Chief/Editorial Board is obliged to ensure an anonymous review of submitted papers before, during and after the evaluation process and authors must remain unknow to the reviewers until the end of review process.

The Editor-in-Chief/Editorial Board is responsible for establishing professional and ethical standards in process and procedures that ensure integrity of published papers by issuing corrections or retracting manuscripts, if necessary. The Editor-in-Chief/Editorial Boards is obliged to keep ideas or privileged information obtained during the review of submitted papers confidential and not to use for any purpose. Author(s) submitting manuscripts for publication in the Journal must ensure that the paper contains reliable data (application of appropriate methods used in data processing, data accuracy etc.). Research results should be published original, without any manipulation or falsification, respecting transparency in the process and support for the publication of the paper and appropriate identification of authors. Author(s) should cite relevant sources used in the papers. Plagiarism of any kind represents a serious violation of publishing behavior. Author(s) are required to guarantee that the submitted papers are original work, not previously submitted or under consideration for publication in another publication. If the paper has been previously submitted to another publication, author(s) are required to provide information on the previous review process and outcomes. In the case where the submitted paper is result of a research project, or its earlier/previous version was presented orally at a conference (under the same or similar title), detailed information about the project, conference etc. must be provided in a footnote at the beginning of the paper. If the paper is the result of a funded project, author(s) are required to indicate the source of funding according to the funding agreement.

If author(s) discover significant errors in already published papers, they are required to immediately notify the editor of the Journal. If possible, the correction will be published or otherwise the paper will be withdrawn.

Reviewers assist to the Editorial Board in making editorial decision as well as the author(s) in improving the quality of the manuscript. Reviewers who do not consider themselves qualified to review submitted manuscripts should immediately notify the Editor-in-Chief/Editorial Board, wo will contact replacement reviewers. The same procedure should be followed if reviewers believe they will not be able to complete the review within the agreed deadline. During the review, the reviewers must be objective, verify the citation of relevant sources in the paper, maintain the confidentiality of the submitted paper they are reviewing and take care to exclude themselves from the review process in the case of conflict of interest.
